1. Call to order 10:00am. All members present except for Bald Eagle, Belleville Mennonite, Bishop Guilfoyle, Glendale, Grace Prep, Hollidaysburg and Purchase Line.
2. Approval of minutes. 1st Cambria Heights, 2nd Richland. Motion passed. Dr. Crumrine addressed the AD's. District VI appreciates all the work the AD's did for the winter sports. District is also working on concussion issues for the membership.
3. Approval of financial report. John Bomboy our Treasurer said very little activity. 1st Greater Johnstown, 2nd Blacklick Valley. Motion passed.
4. Baseball – Chuck Gojmerac – detailed the breakdown of the four brackets. Tournament begins tomorrow with one Class A game and five Class AA games. Thirty two teams entered the 2013 open tournament. Rosters will be requested of all teams in the finals for the programs that will be prepared for the fans.
5. Softball – Don Hosterman – detailed the breakdown of the four brackets. All final games will be played at Penn State on the 29th. Times are TBD and will be announced closer to the date of the finals. Softball has a payroll sheet that the umpires NEED to sign. Make sure they are signed by the umpires. This is slightly different than baseball which does their referee confirmations electronically. Rosters will also be requested prior to the finals.
6. Track & Field – Dean Rossi. Class AA ran last night. Class AAA will be held tomorrow – Thursday May 16th. Computer program used at Altoona gets kids names up on the big screen quickly. Dean mentioned that the workers at Altoona do a very nice job.
7. Tennis – is just about over and all went well. State College represented Class AAA and Westmont Hilltop represented Class AA in the state tournament.
8. Boys Volleyball – Chuck Gojmerac updated the tournament field. Three teams entered Class AA and two entered Class AAA. The district championships will be held at Tyrone Area Middle School on Tuesday, May 21st. Class AA will start at 6:00pm with Class AAA to follow. Regional

play-in games will be held on Thursday the 23rd and the first round of the state tournament starts on Wednesday May 29th with the District VI champions hosting the District VII runners-up.

9. Heat Acclimatization Update – Jr. high football is not permitted to start three days early. They MUST start on the first Monday of legal PIAA practice. PIAA is meeting next Wednesday (May 22nd) and there are some things that may be occurring. Still in a holding pattern, but unless we are notified otherwise, you can plan on using the maximum of five hours. Questions also surround the “dead time” period for school athletes. The down time is up for the third reading on Wednesday and Dean Rossi feels it may not pass. The PIAA does have a heat acclimatization schedule on their website.
10. Accountability Act – Peg Pennepacker. A good number of people are interested in an updated meeting for AD’s, Principals and Business managers. Peg will have a short meeting with the executive committee after the general meeting to determine a good date to host. (AAHS Auditorium will host the symposium on Monday, June 3rd at 10:00am).

Jeff Wheeler at St. Joseph’s, Chuck Terek from Penn Cambria and Luke Rhodes from Tyrone are recognized as new AD’s at their respective schools as new members of our organization. Marion Center asks about a new site for Cross Country for the fall season. On May 30th, District VI will visit Forest Hills to take a tour of their course.
