Call to Order of the August 1, 2012, Meeting

Schools are asked to review the guidelines when available on the PIAA website and return the attached survey (if not already done) to aid in the decision making process. Further discussion is planned for the next meeting.

The new CIPPE form will need to be used beginning with the winter and spring sports to help fulfill the requirements of new legislation regarding the signs of Sudden Cardiac Arrest. There are minimal changes and this form can be downloaded from the PIAA website. The new form is also attached to these minutes along with forms regarding Sudden Cardiac Arrest Information and Warning Signs Information Sheet and Acknowledgement of Receipt and Review Form to be signed by coaches and students who have already completed the old CIPPE.
